AB Persson Invest is a conglomerate, family owned investment company with its head-office in Östersund, Sweden. Total turnover is 7,1 billion Swedish Crowns (SEK). (700 million EUR, 750 million USD). The group employs about 1 360 people.

Locations in central and northern Sweden, in mid-Norway with the base in Trondheim.

The company was founded in 1932 when Sven Persson started as a Volvo dealer. In 2021 the Volvo dealerships for both cars, trucks and buses represented 80% of the turnover.

Other lines of business are; Planing of wood, partly owned sawmill, Real Estate, Forestry and Windmills.






