

Persson Invest

AB Persson Invest is a conglomerate, family owned investment company with its head-office in Östersund, Sweden. Total turnover is 6,2 billion Swedish Crowns (SEK). (620 million EUR, 700 million USD). The group employs about 1 350 people.

Locations in Sweden are from Uppsala/ Västerås and from Östersund and north. Also located in mid-Norway with the base in Trondheim. The company was founded in 1932 when Sven Persson started as a Volvo dealer. In 2019 the Volvo dealerships for both cars, trucks and buses represented more than 90% of the turnover.

Other lines of business are; Planing of wood, partly owned sawmill, Real Estate, Forestry and Windmills.




